CAMPS, SPORTS AND EXCURSIONS FUND (CSEF) POLICY



Purpose:

The Camps, Sports & Excursion fund supports the education of students from eligible families, and therefore needs to be sensitively and effectively managed at school level.

Aim:

- To ensure eligible parents receive the Camps, Sports & Excursion fund payment
- To ensure the allowance is managed effectively at a school level in compliance with relevant DET requirements and parent wishes.

Implementation:

- Details relating to the Camps, Sports & Excursion fund, eligibility, and due dates will be communicated to parents.
- The school will inform parents of the strong likelihood that late applications will be rejected.
- The Camps, Sports & Excursion fund payment cannot be used towards voluntary school charges, books, stationery, out of school hours care, music lessons.
